

Ditchwater and supplemental underground water


## **IMPROVEMENTS**

The houses range from 1,500 square feet to 2,500 square feet and are served by onsite septic, propane tanks, and domestic well water.

## **ROADWAYS**

The property is served by U.S. Highway 395 and Heybourne Road to the east, Airport Road to the south, and Johnson Lane to the north.

## **SOUTH RANCH**

South Ranch comprises 1,548.81 acres across 36 parcels near the southern section of Gardnerville.

1,392 acres of South Ranch is utilized as farmland; the remainder is reserved for rangeland.

#### **IRRIGATION**

- Center-pivot irrigation ranging from 43 to 143 acres
- Roughly six acre-feet of water (ample for the region)
- The western fork of the Carson River forms the Western border of the ranchland, benefiting it and giving the parcels their shape


## **IMPROVEMENTS**

Agricultural operations are based at the western section of the property with structures used for operations.

- 1 small shop
- 2 pump stations
- 1 horse barn
- 3 hay storage barns
- 1400,000 gallon storage tank
- 2 houses (1,350 sq ft [3bd/1ba]; 1,850 sq ft [4bd/2ba]) served by onsite septic and propane tanks
- 2 bunkhouses

#### **ROADWAYS**

The property is served by Anderson Ranch Road and Mud Lake Road to the west, Heritage Lane to the south, Tillman Lane to the east, and Kimmerling Road and Kyndal Way to the north.

## **MIDDLE RANCH + "560"**

## MIDDLE RANCH

Comprises 5,926.48 across 116 parcels in the western section of Carson Valley.

Approximately 4567 acres are utilized as irrigated cropland, 1015 acres of which is irrigated pasture, and the balance is dedicated to agricultural operations.

#### **IRRIGATION**

- Center-pivot irrigation systems which include 25 pivots
- Pipeline and 3 pumping stations with control buildings ranging from four to six pumps
- Some handlines and flood irrigation
- 2 smaller agricultural wells located onsite
- Irrigated with surface water from the Carson River under provisions of the Alpine Decree
- Supplemented by treated wastewater effluent from both Douglas County Sewer Improvement District and the North County pond of the Minden-Gardnerville Sanitation District ("MGSD"). Bently entered into an agreement with MGSD in 2002 and set to expire in 2072<sup>1</sup>



## **IMPROVEMENTS**

Agricultural operations are based at the western section of the property near U.S. Highway 395 and Stockyard Road.

- · Ancillary structures such as an office, shop, houses, cattle handling facilities
- 9 hay barns
- Malt house / feedmill, grain storage for 8,000 tons of grain
- Multiple on site shops, storage areas, and barns
- The houses range from 1,200 square feet (2 bd/1ba) to 1,400 square feet (3bd/2ba) and are served by onsite septic tanks
- Compost yard
- Feedlot

The northern section of Middle Ranch, approximately 1,100 acres, has been designated as a Receiving Area by the Douglas County Planning Department. It is anticipated that the density permitted by current zoning could be increased through the acquisition and transfer of development rights from "Resource Lands" to these areas in order to allow for increased density.

#### **ROADWAYS**

The property is served by U.S. Highway 395, Stockyard Road, and Heybourne Road to the west, East Valley Road and Buckeye Road to the south and west, and Johnson Lane to the north.

<sup>&</sup>lt;sup>1</sup> The contract stipulates that Bently has the right to use, and an obligation to take, the effluent from the district (aside from 750 acre feet reserved by the District). After the initial term (January 1, 2032), Bently is required to pay the District a per gallon price negotiated during that specified ten year term.

## MIDDLE RANCH + "560"

## 560

Comprises 560 acres across 14 parcels east of the southeast section of Middle Ranch.

It is used primarily for winter cattle feeding and calving. Land owned by the Bureau of Land Management is adjacent to the southern and eastern sections of the property. Williams Canyon is located northwest of the site.

## **IRRIGATION**

- The East Valley Reservoir (effluent) is located onsite on eight of the 14 parcels
- Limited access to the site provided by an unpaved roadway

## **IMPROVEMENTS**

 The East Valley Reservoir stores secondary treated effluent under two separate permits: Permit NEV 96003 (effluent supplied by Douglas County SID #1 (DCSID)) and Permit NEV 2002514 (effluent supplied by Minden Gardnerville Sanitation District (MGSD))



• Effluent from the two sources is combined in the storage reservoir which holds 1,784 acre-feet of water


# LONG VALLEY RANCH + MUD LAKE

Long Valley Ranch<sup>3</sup> and Mud Lake comprise 3,669.54 acres across 61 parcels situated in Douglas County, NV and Alpine County, CA; it is surrounded by U.S. Forest Service Land.

The East Fork of the Carson River nears the property boundary at the eastern section of the land near the northern pivot, creating a Horseshoe Bend. An estimated 479 acres of land is utilized as irrigated farmland and includes two pivoted areas; the topography limits further expansion of irrigated farmland.

## **IRRIGATION**

- Surface water intake is located at the southern end of Long Valley Ranch
- There is a well located near the southern pivot
- Water rights that are owned by the Conservancy are used to supplement Carson City water needs in fall and Winter. The water held by the company is used in the irrigation season to irrigate those lands. The total volume for Mud lake is around 5800 acre feet of water
- A 400,000 gallon storage tank located at the western edge of the property



#### **IMPROVEMENTS**

- Mud Lake Reservoir was rehabilitated in 2000 using geosynthetics at a cost of approximately \$7.5 million. The work has a 50-year life expectancy
- 3,748.2 acre feet of water rights stored in Mud Lake; 3,186 acre feet of this belongs to the property owner
- The water is released into the Carson River during the winter for Carson City's municipal and industrial use. The water is considered non-potable, and used as irrigation for South Ranch, Middle Ranch, and other irrigated farmland held by the owner
- If the surface area of Mud Lake covers an approximate 500 acres of the 796.12 acre section of land, the estimated value of Mud Lake as a catch basin would be the annual equivalent of 500 acre-feet of water


